## Remote Monitoring Systems

DualCom ensures a 24/7/365 secure signalling path for the alarm activations and even if the communications line is attacked or develops a fault, an alarm will be generated at the ARC to let you know of an alarm or communications line failure.

## ECA Bond & Guarantee of Work Scheme

The Electrical Contractors Association Bond and Warranty of Work supports the highest level of accountability and protection provided by anybody representing or qualifying electrical companies. It is provided at no additional cost to Registered Member customers!

The bond is a form of contractor insurance and indemnifies all ECA Registered Members' customers for the additional cost of completing contracts if a member's work is terminated for a specified reason, for example, insolvency. The additional cost of completion will be met by the insurer to a maximum limit of £100,000 or 10 per cent of the contract value shown on the bond certificate.

The ECA Guarantee of Work Scheme automatically applies to Registered Members' work, subject to terms and conditions. It covers completed contracts in any calendar year up to a value of £50,000 (including VAT) and £100,000 (including VAT) for multiple contracts for the same customer. The guarantee of Work Scheme is TrustMark compliant and can be used to satisfy Part P regulations. All ECA registered electrical contractors are inspected and assessed regularly to ensure all electrical safety regulations are complied with and that all work undertaken is to the highest standard. The Guarantee is offered at no additional charge to Registered Members.
